

TERMS & CONDITIONS

1. The Artisan herself is required to remain present in the stall, her representatives can not remain present in the stall in her absence. If the artisans herself is not present at the stall she can be restrained from participating in the exhibition for two years consecutively.
2. The Artisans shall at all times follow Covid-19 protocol. She should always wear mask and maintain social distancing. She should at all times follow any other guidelines issued by the Officers of the Corporation regarding Covid-19.
3. As per the information received from the Corporation artisan should reach the stall on time and keep the stall open. She should submit a report of daily sell to the Corporation's staff.
4. The artisans should properly exhibit her work/items/products. She should be polite to all the visitors of the exhibitions at all times.
5. If the woman artisan remains absent after submitting the prescribed fee and allotment of the stall by way of draw, her registration of the stall shall stand cancelled and the fee will not be refunded. The said stall shall be allotted to the eligible person from the waiting list.
6. The Corporation is not liable to reimburse the expenses for the payments made towards travelling, stay and food for the artisans nor any arrangement will be made by the corporation for the same.
7. Although the security arrangements in the exhibition will be taken care of by the Corporation but The artisans are responsible for their personal belongings and she will be responsible for the insurance of her stock/products.
8. Only one person from a family would be allotted stall in the exhibition, if it comes to the notice of the Corporation that the stalls are allotted for more than one person from a family in the exhibition, the corporation reserves the right to cancel the allotment of one of the said stalls.
9. The Artisans at all times should behave in ethical manner, if any artisan found behaving unlawfully/unethically, appropriate action shall be taken against her by the Corporation.
10. The Artisans shall exhibit their products only at the place which have been allotted to them by way of draw. They are not allowed to exhibit their products at any other place at the venue. The Artisans should not misuse to stalls.
11. The Artisans should not engage in conflicts with other artisans.

12. Artisans should follow all the instructions given to them by the officers deputed at the venue of Exhibition.
13. The decisions with regard to allotment of stalls, of the Corporation shall be final.
14. The Artisans are not allowed to take any intoxicating item. They are also not allowed to keep any inflammable items in the stalls.
15. Allotted stalls cannot be transferred by the successful artisan to any other person. Appropriate Penal action shall be taken against the person in case of breach of the condition.
16. Corporation shall not be responsible for the happening of any unforeseen incidents in the exhibitions.
17. The Artisans shall carry their Artisan Card/Photo I card/ Bill Book, Visiting Card in the exhibition.
18. Corporation reserves the right to increase/ decrease the number of stalls or cancel the exhibition at any time.
